

Some concern has developed in reference to a requirement that Scouting units have tax identification numbers for their unit bank account.

As written, section 103-26 of the Internal Revenue Service (IRS) code requires a financial institution to record the tax payer identification number of any person conducting a currency transaction.

A 1973 letter from the Dept. of the Treasury confirmed that units, being integral parts of local, Councils which are tax exempt under section 501 (C) (13), would not be required to have taxpayer identification numbers.

HONOR UNIT AWARD

There seems to be concern about the honor unit process. When does the unit earn this award? The unit earns this award for the month and year it is due to recharter. The units' current year is what the award is based upon. An example is troop 1983 recharters in Dec. the current year for this unit is Dec. 1982-thru december 1983. The unit has 12 months to complete their establish goals and reports their progress during the month of recharter. If troop 1983 began with out a trained Scoutmaster and in December , 1 year later, still has an untrain Scoutmaster this unit does not qualify. If the unit set as a goal to have a trained Scoutmaster and year later at recharter could record a trained Scoutmaster, they would qualify. The ten test of successful Scouting is recorded as a matter of record during the month of renewal. When the renewal papers are turned into the Council Service Center this become the bases for the unit to began meeting its new objectives. Those units recharting during 1983 would received 1983 recognition, and those in 1984 received 1984.

The unit must apply for the recognition items at the time of recharter. On-time charter renewal becomes very important to each unit to received this recognitation. Your District Executive can answer any questions you may have.
